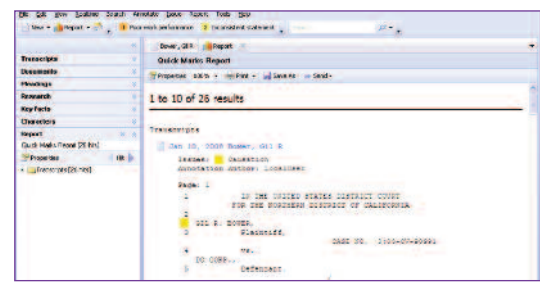


OPTICAL CHARACTER RECOGNITION (OCR)
